8. Detail Scope of Work:-

The scope of work covers supply and painting of structure like pipeline, rack, pressure vessel, ladder, railing, tanks...etc. with synthetic paint/ Epoxy paint in different area of the PM-5, NPP, SPM old plant, boiler, ETP/WTP, AC and Ventilation plant at security paper mill, Narandapuram.

4. While working at height, all safety rules have to be followed and

safety equipment like scaffolding, safety belt and helmet etc. will be in vendor scope of work.

5. The work has to be carried out under all necessary safety rules and regulations

6. The work has to be properly supervised as per EIC.

7. After the painting work, the vendor will also have to do the work of removing paint stains and cleaning.

8. Billing:

a. Bills for jobs shall be certified only on the basis of the data in the Log/Measurement books, Job Order/Job Slip duly certified by EIC.

b. Contractor shall submit only one Bill per month for the work done in previous month.

c. The contractor shall submit bills with detail measurement in quadruplicate in Standard bill format of SPM and maintain one copy of each bill for their records.

9. Facility to be provided by the SPM:

Electricity & water at nearest available one point, free of cost. Further distribution to be done by contractor at their cost as per requirement. One storage space shall be provided free of cost as decided by SPM for the storage of tools and tackle. But vendor should ensure the security of their tools, tackle and material at their own risk.

1. **Required Terms of Delivery:** F.O.R. Security Paper Mill Narmadapuram (Duly Unloaded).
2. **Destination:** Security Paper Mill, Narmadapuram (M.P.)-461005.
3. Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & Forwarding Details, Freight & Insurance Charges up to Destination etc. on FOR Security Paper Mill, Narmadapuram (Madhya Pradesh), India basis only.
4. **Liquidated Damages (LD) Clause:** If the contractor fails to deliver the goods and/or services or any instalment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights and remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liquidated damages, a sum equivalent to the rate of 0.5 per cent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods or services.
5. The terms and conditions, guidelines of SPMCIL Procurement Manual Version 3.0 will be applicable to this bid at any stage to avoid any conflict at later stage. 6. SPM (as Buyer) is liable to deduct TDS u/s 194Q @ applicable rate on goods purchases (if applicable). In case of deduction of TDS under section 194Q; the Supplier (Vendor) need not to charge TCS u/s 206C (1H) on invoicing on or after 01.07.2021.
7. **GST Return:** Supplier should file the GST returns for outward supplies in time. In case of any Input Credit Loss to SPM by way of their failure to file GST Returns in time, SPM reserves the right to withhold the payment of further supplies till production of evidence of filing of Returns.
8. **Service period:** 1 year from the date of issue of GeM purchase order.
9. Bidder shall submit duly seal & signed copy of Scope of Work/Technical Specifications and declaration.
10. **Payment terms:** Payment Terms: Payment shall be done on monthly basis after completion and suitability of service and producing all required essential documents. Payment will be made through NEFT/RTGS only.
11. **Anti-Bribery Management System (ABMS):** By participating in this tender, the suppliers/Vendors/Contractors are deemed to have undertaken that they shall not give or take, any financial or non-financial bribe, to or from anyone during the tender or during the execution of the contract thereafter and if they notice any such incident happening, they shall report it to Vigilance.
12. **Common IP Addresses:** Bidders may please note that GeM is capturing and showing the IP addresses used by the Buyer and the Bidder(s)/Seller(s). The received bids having matching/common IP address with either Bidder(s)/Seller(s) or Buyer, shall be outrightly rejected & shall not be considered for further evaluation.
13. In case a tenderer attempts to influence SPMCIL's decision on scrutiny, comparison, evaluation, and award of the contracts, it will be treated as a serious misdemeanour. In such a case the tenderer shall be liable for rejection in addition to appropriate administrative actions being taken against that tenderer, as deemed fit by SPMCIL, in terms of clause 44 of GIT.
14. **Renewal Clause:** In case, it is not possible to conclude new rate contracts before the expiry of existing ones, due to some special reasons, the existing rate contracts would be extended with same terms, conditions etc for a suitable period, with the consent of the rate contract holders. Rate contracts of the firms, who do not agree to such extension, will be left out. Period of such extension would generally not be more than three months.
15. **Fall Clause:** If the rate contract holder reduces its price or sells or even offers to sell the rate contracted goods, following conditions of sale similar to those of the rate contract, at a price lower than the rate contract price, to any person or organization during the currency of the rate contract, the rate contract price will be automatically reduced with effect from that date (the day of opening of Price Bid) for all the subsequent supplies under the rate contract and the rate contract amended accordingly. Any violation of the fall clause would be considered a serious misdemeanour under clause 44 of the GIT and action, as appropriate, would be taken as per provision of that clause.
16. The bidders (who are otherwise registered for the subject goods) may also be holding current rate contracts and/ or held past rate contracts for the required goods. 17. **Prequalification Criteria:**

If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
