If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

2. **Payment Terms:** Payment shall be made on the basis of per MT production at SPMN carried at Paper Machine and after receipt of satisfactory service as per technical specification (Section VII).

3. Bidder should quote prices inclusive of GST and all cost components such as packing & forwarding details, freight & insurance charges and other charges upto destination etc. on FOR Security Paper Mill, Narmadapuram (Madhya Pradesh), India.

4. **ELIGIBILITY CRITERIA:**

(a) **For MSE/Start-up firm:** The bidder must have capability to provide the relevant services.

(b) **For other firm - Experience and past performance:** The bidder should have experience of having successfully supplied relevant services of **188 Mt.** in any one of the last five years ending on dated 31.03.2025.

Note: Participating bidder needs to submit all related documents along with the bid.

5. **Liquidated Damages (LD) Clause:** If the contractor fails to deliver the goods and/or services or any installment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights and remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liquidated damages, a sum equivalent to the rate of 0.5 Percent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods or services.

7. SPM (as Buyer) is liable to deduct TDS u/s 194Q @ applicable rate on goods purchases (if applicable). In case of deduction of TDS under section 194Q; the Supplier (Vendor) need not to charge TCS u/s 206C (1H) on invoicing on or after 01.07.2021.
8. Vendor has to submit declaration in specified format for the compliance of Section 206AB of Income Tax Act, 1961. In case of non-submission of declaration; TDS will be deducted at higher rates (as applicable) as per section 206AB.
9. GST Return: Supplier should file the GST returns for outward supplies in time. SPM reserves the right to withhold the payment of further supplies till production of evidence of filing of Returns.
10. Bidder shall submit duly seal & signed copy of **Technical Specifications & Quality Control Requirements**.
11. **Delivery Schedule: The contract shall remain valid up to one year from the issue of GeM Contract.**

(i) Services may be availed in staggered manner as per actual requirement.

(ii) SPM shall intimate the about service quantity and date of delivery/ies minimum 30 days in advance through E-mail/letter.

Note:-

- a) The allowable periodic variation would be +/- 5%. Under no circumstances, materials/service will be accepted beyond (+)5% allowed quantity tolerance. Any variation in periodic rate of supply more than (-)5% in each delivery/service schedule would be considered as delay in delivery/service. LD will be imposed on such short supplies/services beyond (-)5% for each delivery/service. This is without prejudice to Force Majeure Clause. In any circumstances, the total Purchase Order qty. will not be exceeded.
- b) The above service schedule may be vary as per our requirement.

12. OPTION CLAUSE:

The Purchaser reserves the right to increase/decrease the ordered quantity by up to 25% at any time, till final delivery date of the contract (or the extended delivery date of the contract), by giving reasonable notice even though the quantity ordered initially has been supplied in full before the last date of Delivery Period (or the extended delivery period of the contract).

13. SHORT CLOSE/ TERMINATION OF CONTRACT:

The Chief General Manager, Security Paper Mill, Narmadapuram, reserve the right at any stage by giving one week's notice without assigning the reason:-

(i) To short close or terminate the order at any time during process of supply against our supply order.

(ii) To reduce the tender quantity at the time of concluding the final supply order.

14. Resolution of Disputes:

If dispute or difference of any kind shall arise between SPM, Narmadapuram and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, unless otherwise provided in the SCC, either SPM, Narmadapuram or the supplier may seek recourse to settlement of disputes through arbitration act 33.2.

15. Quality Control Requirements:

A. Firm will arrange the Best Team to stabilize the program. SPM will provide team during production and bas

ed on the requirement.

B. Firm's Engineer will perform all the required testing (SPM's facilities may be used) based on the system demand and requirement.

C. Lodging, Boarding & Conveyance of Service personal shall be scope of supplier.

16. Technical Specification:

(i) Scope of Supply:

This shall be the service contract with variable cost. Cost shall be calculated on the basis of production booked at paper machine.

(ii) Variable Cost includes:

(i) The Deputation cost of Technical experts/engineers responsible to maintain the "Cobb" value in the range of 40-45.

(ii) To maintain, 'Cobb' with optimum quality, the supply of chemical shall include,

- a. Sizing chemical i.e. AKD,
- b. Defoamer/anti-foaming chemical,
- c. Flocculant and coagulant,
- d. Any other special grade/ special type chemical, if required, to maintain the required "Cobb" value with optimum quality of paper.

(iii) Apart from above mentioned chemicals, other regular/sensitizing chemical shall be provided by SPM.

(iv) Supplier shall ensure the efficient operation of fiber recovery.

(v) Supplier shall be responsible to provide technical assistance to attain desired quality of paper and for this payment shall be made on the basis of per MT production carried at Paper Machine.

(vi) Production quantity shall be tallied through the production booked in SAP at Paper Machine end.

(vii) During the production supplier will depute their representative to ensure quality run of 470 MT passport Paper.

(viii) Any special tool & tackles, pump sets, machinery required shall be arranged by supplier on returnable basis.

(ix) Any special chemicals etc. shall be arranged by supplier on Non-returnable basis.

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate

action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
