6. 7. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 9. - 1. The firm should have registered office in Madhya Pradesh.
- 2. Firm should have valid A Class Electrical Contractor License issued by Chief Electrical Inspector of Govt. of State of MP. If firm possess Class A / Class I License of other state Government, then the firm shall have to get its License endorsed from MP Govt within one month after award of Gem contract.
- 3. The payment will be done on actual basis.
- 4. Firm shall abide all safety rules for ensuring electrical safety and all other statutory rules as applicable for this contract.
- 5. Firm should have work experience of 132KV Voltage or higher voltage, valid Purchase order, work order shall be submitted in this respect along with bid. The same shall be not more than 5 years old.
- 6. All the HT work carried out shall be supervised by supervisor of the firm as per instruction of SPM. The supervisor must have minimum qualification of Diploma in Electrical or Higher with 3 years' experience of HT work.
